#### USEPA CLEAN WATER SRF UPDATE

## Watershed Financing Partnerships (2)

## Using WIFIA and SRF Programs to Finance Water Infrastructure Projects (3)

This factsheet describes how co-funding sustainable drinking water, wastewater, and stormwater infrastructure projects with the WIFIA and SRF programs offers funding recipients efficiencies, cost saving and other advantages.

USEPA recently renewed the <u>Memorandum of Understanding</u> (4) between USEPA State Revolving Funds and FEMA Public Assistance Grants program that can help communities recover quickly after a Presidential-declared disaster occurs. ## USEPA DRINKING WATER SRF UPDATE

Keelan Baldwin provided an update on the Office of Inspector General (OIG) with respect to the lead service estimated number of Lead Service Line Replacements (LSLRs) done by the DWSRF and the funding amount.

The <u>OIG report epaoig.gov</u> (7) on the Drinking Water Infrastructure Needs Survey and Assessment released on October 21<sup>st</sup> provided an extensive response within this report that can be found on page 27. Keelan has encouraged everyone to read it.

## USDA/RURAL UTILITIES SERVICES (RUS) UPDATE

Megan Gernentz from the Water and Environmental Programs(WEP)/Rural Utilities Services (RUS) updated the information that she had provided during the last two meetings. The data that was presented in FY 23 as a guide for FY 24 proved to be accurate. Funding for all of FY 24 is very accurate as compared to FY 23, but the amounts are a little less for each account. There is a higher subsidy rate for the loans. One will see all the different kinds of funding paths of money on the enclosed (8). All the towns received funding, but probably received a little less overall (9).

### USE OF TERMINOLOGY: REGIONALIZATION VS COLLABORATION

A concern has been raised about the use of the term regionalization. Is the term Regionalization too strong and/or threatening? The term may turn off those who support working together. Would not collaboration be a better term?

Ramón Lucero in New Mexico from the Rural Community Assistance Corporation (RCAC) commented that at first, he struggled with the term, but has grown comfortable with it. He noted that in 2023, New Mexico passed the Regional Water System Resiliency Act (10). In response to a question, Ramón noted that RCAP has positive data about regionalization. RCAP uses the term "regionalization" broadly to capture small utility collaborations and partnerships. <a href="https://www.rcap.org/special-initiatives/regionalization/(11">https://www.rcap.org/special-initiatives/regionalization/(11)</a>). Deidre White from ASDWA also supported the use of the term and noted that there are studies in support of regionalization.
